Proposal: Discharge of Conditions Application for DC/25/01214 - Condition 4 (Biodiversity Enhancement Strategy)

Location: Wheatside, Rowes Hill, Laxfield, Woodbridge Suffolk IP13 8HZ.

CONSENT GRANTED - DC/25/04190

Proposal: Notification of works to trees in a Conservation Area - T1 - European Lime to be crown raised by 1.5m-3m over the Suffolk House garden, lower limbs to also be target pruned. T2- small Eucalyptus to be reduced in height, small Himalayan Birch to be removed to ground level to allow the larger more appropriately planted tree to flourish. T5 - Hornbeam to be crown raised by 1-2m and crown reduced by 1-1.5m. T6 - Eucalyptus to be removed to ground level. T7- small weeping judus tree to be target pruned to bring back shape. T8- Large Walnut to be deadwood for safety.

Proposal: Notification of works to trees in a Conservation Area; T1 - Weeping Willow fell to ground level. Re-plant new 4m Cherry in garden to replace amenity value.

PLANNING PERMISSION PARTIALLY GRANTED - DC/25/04115

Proposal: Application for Non-Material Amendment relating to DC/21/05042 - Alterations to PV layout, windows and doors, external patio, decking, and pond.

Changes to layout, windows and doors, external patio and decking were approved. However, the proposed re-location of the pond is considered material and cannot be approved. The pond in its approved location assimilates with the new mixed native woodland, creating a wildlife focused corner within the site. The newly proposed location of the pond appears more an aesthetic garden feature and will have significant visual impact upon the appearance of the domestic garden.
